Fuel Management:

The management system and work system was designed and implemented for the Master or Optimum Management associated with the locomotive's greatest fuel efficiency in several transportation destinations in our trains.

Management Skills Development Module:

The management skills of 77 company leaders were developed and an individual follow-up was carried out to ensure the effective use of the management skills provided by the consulting firm. This generated 1386 man-hours of training.

As an additional support to the management of the leaders in each area, sessions with the
operative personnel were performed with the purpose of breaking paradigms and joining efforts.

These operative improvements are equivalent to an accumulated return on investment (ROI) to this date of 1 to 1, and if the current trend is maintained, the annual projection will allow us to achieve a total ROI of 4.4 to 1 including productivity improvements.

Lastly, we would like to highlight the professional capacity, responsibility and high level of commitment of the entire London Consulting Group team, as well as the focus shown to achieve the target goals and to create an excellent work relationship with the personnel of the company they are working with. Evidence of this is that we have already initiated two extensions in the areas of Management Skills Development, focused towards Operations Skills Management, and the Design of a Management Critical Variable Model.
